BCP Council reserves the right to permit traditional headstones on request. **ONE DEED OF GRANT ONLY WILL BE ISSUED AND SENT TO THE FIRST NAMED PURCHASER.** The Exclusive Right of Burial is purchased giving the owner/s control over the burials in the grave and the right to place a memorial subject to the Council's approval. The ground itself remains in ownership of the local authority.

As a legally registered grave owner you have a responsibility to be conversant with the current Cemetery Rules and Regulations. Please tick this box to confirm that you have read and understood these regulations

*If ownership is granted to one person then that is the only person that can sign to exercise the Right of Burial. If granted to more than one person then ALL of the grantees must sign for the grave to be opened with the one exception being if one of the grantees dies. In this case the deceased grantee has the right by law to be buried in the grave providing there is sufficient space then no further permission from the other grantees is required.*
